The 30<sup>th</sup> May, 2007*High Court Rules  
& Orders Vol. 1*

No. 119/Legis-II.D4(I)-In exercise of the powers conferred by Article 202 of the Constitution of the Islamic Republic of Pakistan, the Chief Justice and Judges of the Lahore High Court, Lahore are pleased to direct that in the Rules and Orders of the Lahore High Court, Lahore, the following amendment shall be made namely:-

AMENDMENT

1. The amendment made in Rule-3. Chapter-13 of High Court Rules and Orders Volume-I, is as under:-

“Rule-3.-Whenever any matter, suit or appeal comes before a Judge in which his own interest or that of person(s)/lawyer(s) of either party, whom he regards and treats as near relatives or close friends, is involved or the order appealed against was passed by himself, he shall refuse to hear the same and at once make a reference to the higher authority for its transfer to another Court”.

In exercise of the powers conferred by Section 9 of the Punjab Civil Courts Ordinance, 1962 and in supersession of the previous Notification No.114/Rules/XXI.C.35, dated 21.03.2000 issued in this behalf, the Hon'ble Chief Justice and Judges are pleased to order that the following classes of Civil Judges shall exercise the pecuniary jurisdiction in respect of original civil suits and proceedings, throughout the Province of Punjab as noted against each:

Civil Judge Class-II to exercise jurisdiction in original civil suit or proceedings wherein the subject matter in amount or value does not exceed Rs.50,00,000/- (Rs.5-Million)

Civil Judge Class-III to exercise jurisdiction in original civil suit or proceedings wherein the subject matter in amount or value does not exceed Rs.10,00,000/- (Rs.1-Million)
