PRESIDENT'S ORDER NO.03 OF 2024

AN  
ORDER

*further to amend the High Court Judges (Leave, Pension and Privileges)  
Order, 1997*

WHEREAS it is expedient further to amend the High Court Judges (Leave, Pension and Privileges) Order, 1997 (P.O. No. 3 of 1997), in the manner and for the purposes hereinafter appearing;

NOW, THEREFORE, in exercise of the powers conferred by the Fifth Schedule to the Constitution of the Islamic Republic of Pakistan, relating to the High Courts, the President of the Islamic Republic of Pakistan is pleased to make the following Order:—

1. **Short title and commencement.**— (1) This Order shall be called the High Court Judges (Leave, Pension and Privileges) (Amendment) Order, 2024.

(2) It shall come into force at once and shall be deemed to have taken effect on and from the first day of July, 2024.

2. **Amendment of paragraph 21, P. O. No. 3 of 1997.**— In the High Court Judges (Leave, Pension and Privileges) Order, 1997 (P.O. No. 3 of 1997), hereinafter referred to as the said Order, in paragraph 21, in sub-paragraph (2), for the words “sixty five thousand”, the words “three hundred fifty thousand” shall be substituted.

3. **Amendment of paragraph 22, P. O. No. 3 of 1997.**— In the said Order, in paragraph 22, after sub-paragraph (2), the following new sub-paragraph (3) shall be added namely:—

“(3) For the purposes of this paragraph, the Administration Committee of each High Court having Benches shall formulate a policy in respect of the vehicles including fuel, maintenance, drivers and inter-bench travel”

4. **Amendment of paragraph 23, P. O. No. 3 of 1997.**— In the said Order, in paragraph 23, for the words “three hundred forty-two thousand four hundred thirty-one”, the words “one million ninety thousand four hundred thirty-four” shall be substituted.

5. **Amendment of paragraph 26, P. O. No. 3 of 1997.**— In the said Order, in paragraph 26, for the expression “If the family of a Judge referred in Article 22” the expression “Subject to paragraph 22, if the family of a Judge” shall be substituted.
